**TRAINING/ WORKSHOP ON THE REVISITING OF SCHOOL IMPROVEMENT  
PLANS (SIPs) IN ALIGNMENT WITH THE 2023-2028 DIVISION  
EDUCATION DEVELOPMENT PLAN (DEDP)**

This division

1. DepEd Surigao del Sur Division has started its implementation of the 2023-2028 Division Education Development Plan (DEDP) to continue the goal of the Department that all Filipinos can realize their full potential and contribute meaningfully to a cohesive nation through the protection and promotion of the right to quality education.
2. As stated in the DEDPs implementation arrangement, there is a need to revisit the School Improvement Plans of all the public schools of the division. The previously crafted SIPs were focused on the 3 priority areas only which are Access, Quality, and Governance. However, with the current Basic Education Development Plan (BEDP) of the department and the Division Education Development Plan (DEDP) of the division, schools need to anchor their SIPs in the 4 pillars, namely: Access, Quality, Equity and Resiliency and Well-Being and the Enabling Mechanism.
3. There is a need of the division to ensure that all education plans, programs, and projects of the schools are consistent with the priorities and strategies in the DEDP and informed by evidence-based research on program effectiveness as they become available to support the annual budget process.
4. In line with this, the School Governance and Operations Division through the Planning and Research Unit will be conducting a Training/Workshop on the Revisiting of School Improvement Plans (SIPs) in Alignment with the 2023-2028 Division Education Plan on February 1-2, 2023. Venue of the activity will be announced later.
5. The objectives of this activity are the following:
  - a. Align School Improvement Plans to the 2023-2028 Division Education Development Plan (DEDP)

- b. Craft programs and projects for Access, Quality, Equity, Resiliency and Well-Being and Enabling Mechanism.
6. Participants of this training/workshop are the CID Chief, SGOD Chief, Chairs of the 4 Pillars of the DEDP, Planning and Research Unit Personnel, and 1 elementary and 1 secondary school head in every district.
7. Participants are required to bring laptop, extension wire, wifi for internet connectivity and their School Improvement Plan for CY 2022-2025.
8. This is a live-in activity. Meals and accommodation of participants will be charged to Division INSET Fund while travelling expenses will be charged to school MOOE/ Local Funds subject to the usual accounting and auditing rules and regulations. First meal to be served will be breakfast of February 1, 2023.
