1. This division aims to institutionalize a result-based management system to strengthen its internal systems and processes to improve access to quality basic education. The DepEd developed the Basic Education Monitoring and Evaluation Framework (BEMEF), which will anchor in the Division Education Development Plan (DEDP). This will serve as a guide in the conduct of Monitoring and Evaluation (M & E) of the department's organizational performance across governance levels.
