WHEREAS, the Inter-Agency Committee on Civil Registration and Vital Statistics (IACCRVS) – Caraga is a recognized Special Committee of the Caraga Regional Development Council (RDC);

WHEREAS, the IAACRVS-Caraga serves as a venue for discussion, issues resolution and identification of workable schemes towards the improvement of civil registration and vital statistics;

WHEREAS, the IACCRVS-Caraga is responsible in prescribing policies and identify strategies in order to meet the target under CRVS Goal 1. Universal civil registration of birth, death, and other vital events.

WHEREAS, the Philippine Statistics Authority (PSA) implemented the Philippine Birth Assistance Project (PBRAP) as one of the strategies to meet the target under CRVS Goal 1. Universal civil registration of birth, death, and other vital events;

WHEREAS, as of December 31, 2022, were 86.68 percent of 50,556 persons or equivalent to 42,309 persons were subject to verification and only 2.01 percent or equivalent to 1,016 persons registered the Certificate of Live Birth in Caraga Region;

WHEREAS, the PSA identified that one of the strategies to meet the PBRAP target is to coordinate with the different schools and identify unregistered learners.

WHEREAS, the PSA seeks the support of DepED-Caraga in the identification and submission of list of unregistered learners by school using Annex A to PSA to facilitate birth registration;
