

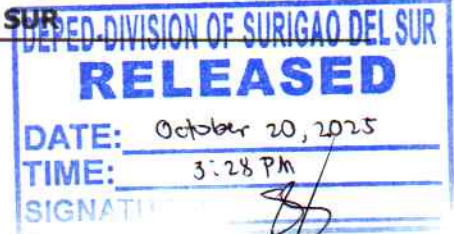

DRUG ABUSE PREVENTION EDUCATION (DAPE)

1. In line with DepEd Order No. 12, s. 2009, titled "Strengthening the National Drug Education Program (NDEP) in Schools," Anti-Drug Advocacy Lectures will be conducted in all secondary schools as part of the ongoing efforts to promote drug awareness and prevention. These lectures will be facilitated by the Philippine Drug Enforcement Agency (PDEA), in close collaboration with the Provincial Anti-Drug Abuse Council (PADAC), the Philippine National Police (PNP), and the Sangguniang Kabataan (SK). This initiative aims to reinforce drug education and awareness among students, promote a drug-free learning environment, and strengthen community involvement in the campaign against illegal drugs.
2. All secondary schools, particularly the Project Development Officers responsible for facilitating the activity, are hereby directed to coordinate with their respective Local Government Units (LGUs) to ensure the smooth implementation of the Drug Abuse Prevention Education (DAPE) program. Attached are the official schedules for the DAPE activities, along with the letter request from the Philippine Drug Enforcement Agency (PDEA) outlining the details of the initiative.
