**CONTINUATION OF THE BLUE ALERT STATUS OF CARAGA RDRRMOC ICOW LOW
PRESSURE AREA (LPA) FORMERLY TD "QUENNIE"**

1. Enclosed is RM No. 0957, s. 2022 relative to the RDRRMC Memorandum Circular No. 59, s. 2022 on continuation of the Blue Alert Status of Caraga RDRRMOC on LPA formerly TD' Quennie".
2. Based on the available data from PAGASA, at 10:00 AM today, the low pressure (formerly "Quennie") was estimated at 420km East Southeast of Hinatuan, Surigao del Sur. Although TD weakened, the trough of LPA will bring light to moderate with at times heavy rains over Eastern Visayas and Caraga. Under these conditions, flooding and rain induced landslides are possible, especially in areas that are highly or very highly susceptible to these hazards as identified in hazard maps in areas with significant antecedent rainfall.
3. With this, all schools in this division shall remain on alert status for possible flooding and landslides.
4. School Heads must ensure the safety and protection of learners and personnel from unnecessary dangers that they may be exposed to during natural disasters and also coordinate to respective local DRRMOs for any updates and report any natural hazards found within or around the school premises for risk assessment and possible advice on class suspension if necessary.
5. Please be guided with DO 37, s. 2022 Guidelines on the Cancellation or Suspension of Classes and Work in Schools in the Event of Natural Disasters, Power Outages/Power Interruptions, and Other Calamities.
6. Widest dissemination of this memorandum is highly recommended.

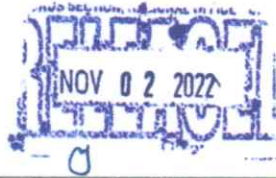

CONTINUATION OF THE BLUE ALERT STATUS OF CARAGA RDRRMC
ICOW LOW PRESSURE AREA (LPA) FORMERLY TD "QUEENIE"

1. All DepEd Offices are hereby informed of the RDRRMC Memorandum Circular No. 59, s. 2022, issued today, November 2, 2022 at 11:00AM.
2. Despite the TD Queenie becoming a Low-Pressure Area (LPA), Caraga RDRRMC Operation Center shall continue its Blue Alert Status (second stage of alert) to closely monitor all related incidents and ensure prompt coordination with all concerned agencies.
3. With this, all schools shall remain on alert status for possible continuous flooding and landslides in their areas which may affect the full implementation of in-person classes.
4. For LGUs with lifted class suspension or cancellation, school heads shall ensure that the learners and personnel are safe to return to schools specially those areas with signs of possible secondary hazards such as softening/eroding of soil/ground, hills, or continuous rising of water levels in rivers/lakes where the schools are nearby situated.
5. School Heads shall coordinate with their local DRRMOs for any updates and report any natural hazards found within or around their school premises for risk assessment and possible advice on class suspension if necessary given the situation.
6. Be reminded as well that the parents or guardians have the discretion or decision to determine whether or not it is safe to send their children to school per DO 37, s. 2022.

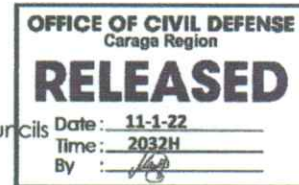

Date : November 1, 2022

1. Reference:

- DOST-PAGASA Tropical Cyclone Bulletin No. 6 issued at 5:00 pm, 1 November 2022;
2. At 4:00 PM today, The Low Pressure Area (LPA) formerly TD Queenie was estimated based on all available data at 420 km East Southeast of Hinatuan, Surigao del Sur. Although TD Queenie weakened into remnant low at 2:00 PM today, it is still bringing heavy rainfall over Caraga Region and Davao Oriental. Under these conditions, flooding and rain-induced landslides are possible, especially in areas that are highly or very highly susceptible to these hazards as identified in hazard maps and in localities with significant antecedent rainfall.
 3. In view of this, the Caraga RDRRMOC will continue its BLUE ALERT Status to closely monitor, consolidate and report all related incidents and ensure prompt coordination with all concerned agencies and offices;
 4. Relative to this, all RDRRMC-member agencies and Local DRRM Councils are advised to continue the monitoring and coordination and to ensure widest dissemination of alerts and warnings for possible flooding and landslide to areas that are highly or very highly susceptible to these hazards.

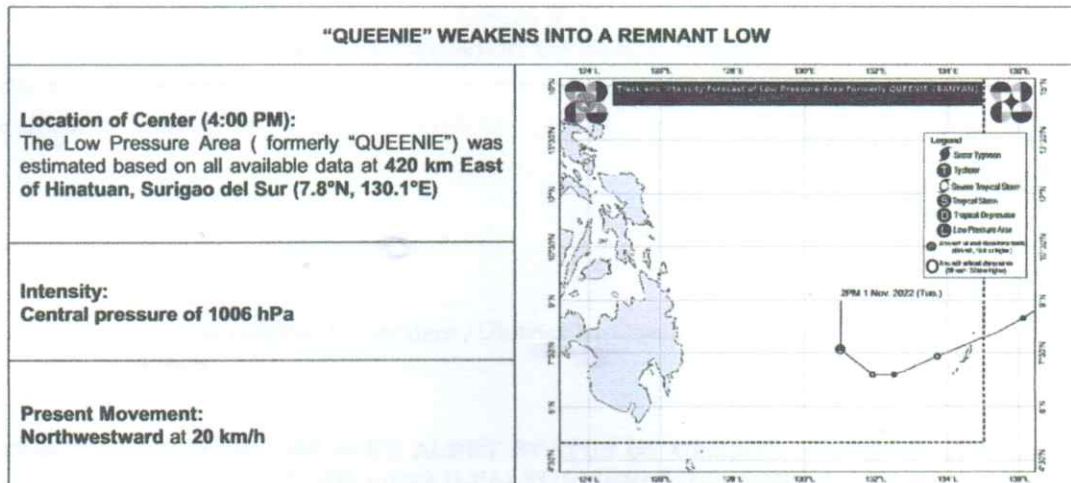

TROPICAL CYCLONE BULLETIN NO. 6F
Low Pressure Area (formerly "QUEENIE")
Issued at 5:00 PM, 01 November 2022



TROPICAL CYCLONE WIND SIGNALS (TCWS) IN EFFECT
No Wind Signals currently in effect

HAZARDS AFFECTING LAND AREAS
This afternoon through tomorrow morning, the remnant low may bring light to moderate with at times heavy rains over Caraga and Davao Oriental. Under these conditions, flooding and rain-induced landslides are possible, especially in areas that are highly or very highly susceptible to these hazard as identified in hazard maps and in localities with significant antecedent rainfall.
HAZARDS AFFECTING COASTAL WATERS
The remnant low is unlikely to bring rough seas over the coastal waters of the country which may result to risky conditions to mariners.
TRACK AND INTENSITY OUTLOOK
QUEENIE weakened into a remnant low at 2:00 PM today. This remnant low will continue moving generally northwestward and may dissipate in the next 12 hours.

Considering these developments, the public and disaster risk reduction and management offices concerned are advised to take all necessary measures to protect life and property. Persons living in areas identified to be highly or very highly susceptible to these hazards are advised to follow evacuation and other instructions from local officials. **For heavy rainfall warnings, thunderstorm/rainfall advisories, and other severe weather information specific to your area, please monitor products issued by your local PAGASA Regional Services Division.**

Unless re-development occurs, this is the final bulletin for this weather disturbance. Succeeding updates will be provided in the 24-Hour Public Weather Forecast at 4:00 AM tomorrow.
