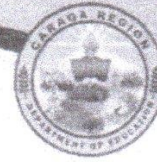

ASSESSMENT OF THE SCHOOL-BASED MANAGEMENT PRACTICES IN CY 2019

TO: SCHOOLS DIVISION SUPERINTENDENTS
 This Region

1. School-based management (SBM) is a strategy to improve education by transferring significant decision-making authority from the Central Office to the individual schools. It provides principals, teachers, students, and parents greater authority, responsibility and accountability over the education process by giving them responsibility for decisions about the budget, personnel, and the curriculum.
2. Through the active involvement of teachers, parents, community members and other stakeholders in these key decisions DepEd Caraga Region was able to recognize a total of twenty-six (26) schools whose practices are in "Advanced" Level.
3. As we embrace this notable accomplishment, the field is hereby informed of the schedule and guidelines in assessing SBM Practices for CY 2019. To wit,

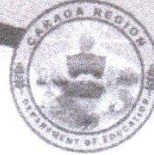

4. Only schools with letter of intent duly endorsed by the Schools Division Superintendents shall be validated. Validation shall cover Document Analysis, Observation and Discussion (D-O-D).
5. The Validation Process shall be managed by the Regional SBM Coordinating Team which shall be composed of the different personnel from the Regional Office.
6. All schools recognized as Level 2 practitioners in CY 2018 are encouraged to apply for re-validation.
7. Only schools with a rating of **Advanced Level** in the **Performance Indicators (PI)** e.g. Access and Quality shall be endorsed to undergo the D-O-D Process. Hence, a hard copy of the SBM Validation Tool shall be attached to the letter of intent duly signed by the school head, District Supervisor and Schools Division Superintendent.
8. This Office will no longer accept letter of invitation and endorsements beyond the deadline.
