**MONITORING COMPLIANCE WITH PRE-SESSION 3 REQUIREMENTS FOR
 KHAN ACADEMY INTEGRATION TRAINING PROGRAM**

1. In line with Regional Memorandum No. 0915, s. 2025, the Schools Division Office will monitor compliance with the pre-Session 3 requirements for the Khan Academy Integration Training Program. Session 3, "Data-Driven Teaching with Khanmigo AI Tools," set on October 19, 2025, will focus on advanced dashboard analytics and AI-powered teaching support to address learning gaps and improve instruction.
2. School Heads with Khan Academy implementing teachers must ensure that all preparatory activities are completed before the training. PSDSs and DICs shall oversee and verify compliance at the district level.
3. Compliance monitoring guidelines and verification procedures are available at <https://tinyurl.com/KAPhS3Preps>. School Heads are required to compile and retain all necessary documentation to support the verification process.
4. Teachers eligible to participate in Session 3 must meet the following criteria: a. Completion of Session 2 (either during the previous school year implementation or on August 9, 2025). b. Fulfillment of all pre-Session 3 requirements. Eligible participants include Mathematics, Science, and ALS teachers from Grades 1 to 12, along with other designated education personnel.
5. School Heads are directed to coordinate with their respective Division Math Supervisors for compliance verification and submit all required documents by **October 6, 2025**.
6. Immediate dissemination of this memorandum is desired.
