4TH QUARTER MONITORING OF SCHOOL MOOE FOR CY 2021

To: Public Schools District Supervisors/ In charge All School Heads

- This Office promotes efficient disbursement of funds as mandated by DepEd Order No. 13, s. 2016 and DepEd Order No. 008, s. 2019 re: Implementing Guidelines on the Direct Release and Use of MOOE Allocations to all schools through cash advances.
- 2. Anent to this, the School Governance and Operations Division (SGOD) is tasked to conducting a quarterly monitoring of MOOE liquidations. It is reiterated, that only those who are able to fully liquidate their current MOOE shall have the privilege of a downloaded succeeding MOOE allocation.
- 3. Moreover, all Public Schools District Supervisors/ In charge are enjoined to intensify the tracking of cash advances for 4th quarter by making sure that all schools with unsettled transactions are able to cope with their lapses. Failure to appropriately manage the funds hampers the basic and general services of the school. Deadline for submission of the report is on January 7, 2022 @ sdsmande@gmail.com.
