- 3. The information provided in the table must be supported by the appropriate document. For example, in the column under Proof of Ownership/Occupation, the school head must attach a copy of the title or the latest tax declaration, as the case may be. The same is also true in the column Mode of Acquisition. If the area was acquired through donation, sale or awarded by virtue of a presidential proclamation, the Deed of Donation, Deed of Sale or a copy of the Presidential Proclamation must be attached. If the school site has already been titled and the original copy has been submitted to the Division Office, kindly indicate the same in the Remarks/Status column.
- The data gathered in this school site inventory will be used as a basis for the utilization of funds released or maybe released in the future for survey and registration of title from the Central Office.
- The above-stated information shall be collected & consolidated by the District Supervisors/DIC's and shall be submitted to the Legal Unit at the Division Office on or before December 15, 2020.
