1. Pursuant to DepEd Memorandum No. 94, s. 2016 on "*Promotion of Online Child Protection and Prevention of Cyberbullying*," this division promotes the protection of all learners from the potential risks of online abuse, exploitation, and bullying through the use of Cybersafe Online Lesson Plans for Grades One to Four, Grades Five to Six, and Junior High School.
2. In view of this, the Department of Education and Stairway Foundation, Inc. (SFI) shall conduct a **Cybersafety Training of Trainers (ToT)** for Regional and Division personnel and teachers of Regions II, V, SOCCKARGEN, and CARAGA.
3. The blended training course is divided into three parts: the (i) **Foundation Course on Child Protection** will be conducted online asynchronously through the SFI E-Learning Website while the (ii) **Understanding Cybersafety Course** will also be conducted online asynchronously through Google Classroom. The (iii) **Cybersafety Webinar** will be conducted online synchronously through Zoom Cloud Meetings.
