Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bid Documents will be available only to prospective bidders starting **July 19, 2021 to August 11, 2021** during office hours, upon payment of a nonrefundable fee for the Bidding Documents in the amount as stated above.
