The Department of Education – Surigao del Sur Division, through the FY 2022 General Appropriations Act (FY 2022 GAA) intends to apply the sum of Eighty One Million Four Hundred Sixty Four Thousand Eight Hundred Eighty Pesos Only (Php 81,464,880.00) being the ABC to payments under the contract for Procurement of Learning Resources for the Implementation of Basic Education Learning Continuity Plan (BE-LCP) CY 2022. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The DepEd – Surigao del Sur Division through the Bids and Awards Committee (BAC) now invites bids for the above Procurement Project. Contract duration is forty five (45) calendar days after receipt of the Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from DepEd – Surigao del Sur Division and inspect the Bidding Documents at the address given below during working days (8:00am – 5:00pm).

5. A complete set of Bidding Documents may be acquired by interested Bidders starting on April 11, 2022 (office hours only) and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, as stated above.

It may also be downloaded from the website of Philippine Government Electronic Procurement System (PhilGEPS) and the Procuring Entity's website, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of bids.

6. The DepEd Surigao del Sur Division will hold a Pre-Bid Conference on April 19, 2022 at 10:00am through video conferencing or webcasting via <https://tinyurl.com/prebidbelcp003> which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the Procurement Section of the DepEd-Surigao del Sur Division on the indicated address below on or before 10:00am of May 3, 2022 (Tuesday). Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

9. Bid opening shall be on May 3, 2022 (Tuesday) at 10:01am at 3rd Floor DepEd Division Office Conference Hall – Balilihan, Mabua, Tandag City and live via <https://tinyurl.com/biddingbelcp003>. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

10. The DepEd Surigao del Sur Division reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
