Delivery of the Goods is required within *30 Calendar Days*. Prospective bidders must have completed a similar contract within the last ten (10) years from the date of submission and receipt of bids with an amount of at least 50% of the ABC to be bid.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

A complete set of Bidding Documents may be purchased by interested Bidders on **September 16, 2020 – October 6, 2020 @ 8:00am to 5:00pm** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of *Five Thousand Pesos (5,000.00)*.

The **Dep-Ed, Division of Surigao del Sur** will hold a **Pre-Bid Conference** on **September 24, 2020 @ 10:00 AM** at *3<sup>rd</sup> Floor Division Office Conference Hall* which shall be open only to all interested parties who wish to join the Bidding.

Bid opening shall be on **10:00 AM of October 6, 2020** at **Third Floor Division Office Conference Hall**. Bids will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.

The **Dep-Ed, Division of Surigao del Sur** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
