**PROJECT PPE - EXEMPLAR DEVELOPMENT PHASE WRAP UP AND
SELF-LEARNING MODULES PRINTING AND REPRODUCTION**

To: Public Schools District Supervisors & Districts In-Charge
Elementary and Secondary School Heads
This Division

1. Division Memorandum No. 282, s. 2020 dated August 5, 2020 directed schools to prioritize the printing and reproduction of Project PPE exemplars that can be used in the first two weeks of the first quarter. Along with it are the regionally crafted and quality assured Grade 8 SLMs which shall be paired with its counterpart PPE exemplars to supplement and help the learner grasp and assimilate the Most Essential Learning Competency (MELC).
2. With the onset of funds for Central Office-released self-learning modules (SLMs) and the modules itself which have been gradually becoming available, the District PPE Management Teams are now directed to wrap up the development phase of exemplars, until further notice. However, quality assurance of the exemplars developed until this point shall continue until these get uploaded in the *LRlinked* site.
3. The schools are now directed to start the printing and reproduction of the SLMs, targeting the modules designed for second week of September onwards. The pairing of the SLMs with PPE exemplars as supplementary learning resource shall carry on until its availability is expended.
4. Senior High Schools are hereby directed also to print and reproduce the SLMs starting on the first week modules onwards, especially the subjects outside the scope of Project PPE.
5. In the event that the PPE exemplars are completely consumed, schools may adopt the portfolio assessment approach as a method of measuring the performance of the learners using the SLMs. The portfolio assessment prototypes provided through the PPE Essentials Google drive or in this link <https://bit.ly/Portfolio-Prototypes> are in editable forms for re-alignment or contextualization.
6. Should there still be learning areas neither in the catalog of SLMs and PPE exemplars, schools shall use the learner's materials (LMs) or textbooks (TXs) paired with activity sheets. There are various activity sheets and other

supplementary learning resources downloadable from the *LRlinked* site and DepEd LR Portal that could be paired with the LMs and TXs. The teachers are enjoined as well to develop contextualized activity sheets.

7. Subject to the unique context of the school's learning delivery modality (LDM) and context, the reproduction of the SLMs shall be strategic, geared toward cutting budget cost and decongesting the tasks of the learners for a week. Refer to the class grouping scheme contained in Division Memorandum No. 282, s. 2020.
8. Supplies such as bond papers, printers, inks, and other appropriate supplies and materials will be provided to schools or district offices from allocated funds per Regional Memorandum No. 315, s. 2020.
9. The SLMs, PPE exemplars and supplementary LRs can be downloaded from the *LRlinked* site embedded in ehris.depedsurigaodelsur.com. Unauthorized activities such as sharing of digital files other than the intended purpose are strictly prohibited and shall be grounds for imposition of administrative and other sanctions.
