1. In line with the implementation of Indigenous Peoples Education (IPEd) Program, a **Division Retooling Teachers Newly Assigned in Schools Implementing Indigenous Peoples Education Program** *December 21-23 2021* at the venue to be announced later. This is to retool the teachers with the different basic principles and policy statements outlined in the national IP Education Policy Framework (DepEd Order No.62, s.2011) and the IPED Curriculum Framework (DepEd Order No.32, s.2015) and other the legal basis in implementing the program.
2. The enabling objectives of the activity are the following:
 - a. To develop a holistic perspective on the overall learning and social-cultural context of IP communities.
 - b. To gain and develop the new set of skills related to research, teaching approaches, techniques and development of learning tools that will help them be effective of teachers of schools serving IP communities; and
 - c. To commit to a conscious effort of engagement in devising and implementing initiatives aligned basic principles and policy statements outlined in the National IP Education Policy Framework (DepEd Order No.62, s.2011) and the IPED Curriculum Framework (DepEd Order No.32, s.2015) through the preparation of their action plan.
3. Attached is the *Authority to Travel* of the participants for the training.
4. Expenses incurred during the training such as meals, accommodations, honorarium and TEV of elders and ritual materials are chargeable to IPED Program Support Fund 2021 while travelling expenses of all participants are chargeable to School MOOE/Local funds subject to accounting rules and regulations.
